

**Domino's® "Taco Tuesdays" Twitter Giveaway
Official Rules**

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Domino's® "Taco Tuesdays" Twitter Giveaway (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least thirteen (13) years old at the time of entry. Employees of Domino's Pizza LLC, Merkle Inc., and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules. Sponsor's and Administrator's decisions are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

Timing: The Sweepstakes is open on August 25, 2020, beginning at 10:00 a.m. Eastern Time ("ET") and ending on September 15, 2020 at 11:59 p.m. ET (the "Promotion Period"), and consists of four (4) one-day Entry Periods each Tuesday as set forth in the chart below. Twitter's servers are the official time-keeping devices for the Sweepstakes.

4. How to Enter: To participate you must have a Twitter account. Twitter accounts are free, but subject to Twitter, Inc.'s terms of service: (<https://twitter.com/tos>). Your account settings must be set to "unprotected" and/or "public" in order for your Tweets to be viewable by Sponsor and its agents. If you Tweet using your wireless phone, message and data rates may apply. Please consult your wireless-service provider regarding its pricing plans.

During the Promotion Period, Sponsor will post one (1) Tweet advertising this Sweepstakes. Take the following actions to receive one (1) entry into the Sweepstakes drawing associated with applicable Entry Period drawing:

- (1) Retweet Sponsor's Tweet that includes the hashtag #WinDominosPizza and the link to these Official Rules: <https://bit.ly/2Q0SbdZ> and comment including tagging a person with whom you have a personal relationship;
- (2) Your need not include any additional content with your Retweet. However, if you choose to include additional content, it must be your original work and must not be indecent, obscene, hateful, tortious, defamatory, libelous, contain material that violates or infringes another's rights, disparage Sponsor, or any other person or party, or contain material that is unlawful in any way; and
- (3) Your Twitter account must remain public and you must not change your Twitter handle until all prizes are awarded.

You automatically will receive one (1) entry into the Sweepstakes drawing for the applicable Entry Period for your qualified Retweet. Sponsor may disqualify your Retweet if it determines that it finds it to be unlawful, or in violation of these Official Rules. Released Parties (as defined in Section 7, below) are not responsible for lost, late, unreceived, damaged, incomplete, invalid, un-intelligible, or delayed Retweets or

failure to receive the Retweet due to limitations of third-party social network platforms all of which will be void.

Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different Twitter accounts, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the Twitter account used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses used to create the Twitter account. The potential winner may be required to show proof of being the authorized account holder.

5. Prize Drawings: Administrator is an independent judging organization whose decisions as to the administration and operation of the Sweepstakes drawings and the selection of the potential winners are final and binding in all matters related to the Sweepstakes. The potential winners will be notified by @Dominos as a reply message on Twitter and will be required to follow the instructions to provide their name, email address and home mailing address to confirm eligibility and for prize fulfillment purposes within three (3) days of the date notice or attempted notice is sent, in order to claim a prize. In addition, the "Friend" who was tagged in the potential winner's Retweet will also be offered the prize by @Dominos. The Friend will also be directed to provide his/her name, email address and home mailing address to confirm eligibility and for fulfillment purposes within three (3) days of the date notice or attempted notice is sent, in order to claim the offer. If a potential winner of a prize or Friend cannot be contacted, fails to provide any requested information within the required time period, or the prize/offer is returned as undeliverable, the potential winner or Friend forfeits the prize/offer. Receiving a prize is contingent upon compliance with these Official Rules. For all prizes and offers: Terms and Conditions of the e-gift card apply. Prizes are non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute the prize for one of equal or greater value if the designated prize should become unavailable for any reason. Winner is responsible for all taxes and fees associated with prize receipt and/or use. Odds of winning a prize depend on the number of eligible entries received associated with each Twitter Post during the Promotion Period. Prizes will be fulfilled approximately 8-10 weeks after the conclusion of the Sweepstakes.

7. Disputes: Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Michigan (Southern Division) or the appropriate Michigan State Court located in Oakland County, Michigan; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Michigan without giving effect to any choice of law or conflict of law rules (whether of the State of Michigan or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Michigan.
